- Brief review of last month minutes
- Announcements/Updates:
 - Mac-Reports recent meeting with CHSC, Family Links, Safety Net, Ed Haberchak, Rich Venezia, Sue Scheuring (City), Bethlehem Haven and few others. They are looking for strategy to assist increasing numbers of individuals using The HUB. There is a significant lack of participation. One reason identified is that there is a lack of funding for The HUB for outreach. They employ one MH counselor and one case manager. Mac suggested coordinating with the other outreach agencies to help increase the numbers for the transitional age group. There is reported an encampment of the transitional age kids in Schenley Park. Stephanie reports that OSN does steer the appropriate age individuals to The HUB. On average, it is reported that roughly 2-8 individuals are attending regularly. Three Rivers Youth (whom the HUB falls under) has housing for employed and higher than welfare income individuals, both male and female housing. Some issues discussed: Are the rules of the HUB deterring folks to attend? The logistics of the HUB, is it the location that deters? It was noted that when the cork factory in the Strip District closed, numbers at the HUB significantly decreased. Holley mentions that she is familiar with the rules of the HUB and does not find that they are that strict in her personal opinion, but does report that there are probable inconsistencies with these rules. This age group also is with

- problems with authority/rules/etc. There will be a meeting again in about one month, Mac will update.
- Jonathan Cox updates re: panhandling ordinance. He brought "City of Pittsburgh Text File" copy of ordinance that was presented 7/26/05 @ Public Safety Services Committee. The Pittsburgh Downtown Partnership (PDP) supports the amended panhandling legislation. The ordinance will be presented next week in committee on Wed. Final council session is the following Tuesday. This is the legislation that the PDP wanted, but the expediency took them by surprise. Draft of ordinance is supported 100% by PDP. Mac received call from Post Gazette. Homelessness didn't come up in the Post Gazette articles, which is very positive. PANHANDLING does NOT equal HOMELESSNESS. The first ordinance was never enforced to Mac's knowledge. It primarily addressed aggressive panhandling. New ordinance still addresses aggressive panhandling and further outlines/defines behaviors allowed/not allowed: such as restrictions on the times of panhandling, where it can occur, etc. Downtown officers are taking more seriously, more offenses and pushing jail.
- o Chris asks goal of PDP on panhandling/homelessness. Response: Pains have been taken throughout ordinance and ad campaign to separate panhandling/homelessness. PDP is not just for the business organizations; downtown business, private and foundations fund it. Goal is to make downtown a safe, attractive, vibrant area. Goal for increased living and development of downtown. Making downtown a healthier place. Core downtown is in "rough" shape right now. Panhandling is only one of the many issues.
- Diane-Panhandling is only one factor. Panhandling increase is a symptom, so what is the root? Chris reports POVERTY, which is something we cannot solve. Mac asks for PDP backing in HOCC push for things such as the Engagement Center. Panhandling: often have signs of "homeless, please help", but may are not homeless and give the homeless a "bad name". Is the goal to ban/eliminate panhandling? Then leading to loitering laws, vagrancy laws then banning homelessness? PDP reports primary goal is to also educate the public such as: giving money to an organization en lieu of money to panhandlers to support an addiction or something else. There is attempt in achieving a balance. The ordinance is phrased on what a panhandler can do. No underlying motives to further restrict panhandling per Jonathan.
- Blaine-suggests that the ordinance be put in place and see how it goes.
 Overall response of the group was "NO", as once put in place it is LAW.
 We all need to be diligent/careful to not somehow inadvertently affect the homeless. Overall, HOCC does agree with the PDP goal(s).
- General discussion related to ordinance: Violation fines of ordinance discussed: \$25-\$50 fines for citations, will this be a deterrent? Rocky discussed how this will lead to citations, failure to show to hearings, bench warrants being issued and then issues with jailing individuals leading to more cost and further overcrowding. Mac voices concerns regarding individual's civil rights, such as street vendors. Jonathan reports vendors have permits and should not have any issues with ordinance. Dennis mentions concern for panhandling fines/warnings/citations/etc, as these will probably vary from police officer to officer. Officers are not educated related to panhandling and how this does not equate to homelessness per se. Also, an issued citation: need address to send info on court date/time/location. If homeless, they won't receive/may not receive this info which will also

result in bench warrant. Jonathan does bring up that the downtown police officers do know the regular homeless downtown. ??Will there be a public hearing?? The point was raised that Vic W. can't do anything until the ordinance is passed as law. Diane discussed that the ordinance thus far is firmly fair. We don't want to see aggression. There is concern regarding the time restrictions in the ordinance. Two things an individual can do if interested: 1. talk to City Council 2. Attend any public forums. Next Tuesday is council formal then Wednesday is the committee discussion (public forum is before this). Mac will get the specifics of next Wed. Interestingly, Mr. Bodack initiated the presentation of the ordinance; this was not initiated by City Council. This ordinance encompasses the ENTIRE CITY. This also encompasses organizations, too—such as the Fireman's donation collection, Salvation Army donation collection, ETC. Vic W. (per Mac) has expressed concern re: 1st Amendment Rights-rights don't disappear when the sun sets! Also, concern re: discrimination if you don't have a talent such as guitar, bell, etc to be a "street performer".
